CITY ORDINANCE NO. 2018-08**

**AN ORDINANCE DECLARING THE MONTH OF MAY OF EVERY YEAR AS "SAMPAGUITA MONTH" IN THE CITY OF SAN PEDRO, LAGUNA.**

**WHEREAS**, the Sampaguita flower which was thriving in the then Municipality of San Pedro, Laguna is given importance by our City Government due to its contribution to the life of our residents in terms of income;

**WHEREAS**, the month of May is considered the Flower Month since most of the plants blooms and produces flowers in the said month hence supply of Sampaguita buds is abundant;

**NOW THEREFORE**, be it enacted by the Sangguniang-Panlungsod of the City of San Pedro, Laguna in its regular session duly assembled, that:

**SECTION 1.** The month of **MAY** of every year is hereby declared as **SAMPAGUITA MONTH** in the City of San Pedro, Laguna.

**SECTION 2.** The **Sampaguita Festival** shall be held any day or week within this month


